Subject: Declaration of Final Result of Combined Recruitment of Junior Hindi Translator, Junior Translator, Senior Hindi Translator and Hindi Pradhyapak Examination, 2018 - reg.

Paper-II of Junior Hindi Translator, Junior Translator, Senior Hindi Translator and Hindi Pradhyapak Examination – 2018 was held on 26.05.2019. The result of Paper-II for calling candidates for Document Verification was declared on 04.09.2019.

2. Keeping in view the vacancy position, category-wise details of the 104 candidates qualified for appointment to various posts in different Ministry/ Departments/ Offices are as given below:

Allocation of Posts and Departments to the qualified candidates has been made on the basis of merit-cum-'order of preference' of 'Department' exercised by the candidates at the time of Document Verification.

3. Category wise break-up of the candidates selected for the posts of Junior Hindi Translator, Junior Translator and Senior Hindi Translator along with the marks obtained and Date of Birth (DoB) of the last selected candidates are given below. 6. Resolution of Tie cases: In case where more than one candidate secured the equal aggregate marks, tie has been resolved by applying the following methods one after another in the given order till the tie is resolved:

- (i) Total marks in Paper-II.
- (ii) Total marks in Paper-I.
- (iii) Date of birth, with older candidates placed higher.
- (iii) Alphabetical order in the names of the candidates.

7. There are some candidates whose candidatures have been kept as provisional by the concerned Regional Offices but are also included in the Select List. Concerned User Departments will check the eligibility of such candidates thoroughly at the time of nomination.

8. Any discrepancy with respect to the selection/ non-selection/ allocation of post/ User Department, etc may be brought to the Notice of the Commission within a period of one month. Any such representation received after one month will not be entertained by the Commission.

9. If a candidate is finally selected and does not receive any correspondence from the Commission or the concerned User Department within a period of one year after declaration of result, he/she must bring this to the notice of the User Department immediately thereafter.
